

ORDINANCE 15-2015

ORDINANCE OF THE BOROUGH OF MADISON REPLACING ORDINANCE 1-2014 PERTAINING TO PART-TIME NON-UNION SALARIES AND OFFICES

WHEREAS, certain changes are required in the salary ranges for non-union part-time employees;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Madison, County of Morris, State of New Jersey, as follows:

Section 1. Ordinance 1-2014 is hereby replaced by this ordinance in order to change the salary ranges for certain non-union, part-time employees, as follows:
