

ORDINANCE 56-2008

ORDINANCE OF THE BOROUGH OF MADISON AMENDING ORDINANCE 24-2008 TO APPROPRIATE AN ADDITIONAL \$6,750.00 FOR A TOTAL AMOUNT OF \$156,750.00 FROM THE FUND BALANCE ACCOUNT CONTAINED IN THE GENERAL CAPITAL FUND AND AMENDING ORDINANCE 24-2008 AS TO PURPOSE OF SAID ORDINANCE TO PURCHASE A MULTI-USE MUNICIPAL LOADER MOUNTED ON A HEAVY DUTY TRUCK CHASSIS

WHEREAS, Ordinance 24-2008 of the Borough of Madison appropriated \$150,000.00 from the Fund Balance Account contained in the General Capital Fund to purchase a new catch basin cleaner truck and accessories; and

WHEREAS, the Superintendent of Public Works has recommended that the Borough amend Ordinance 24-2008 to appropriate an additional \$6,750.00 from the Fund Balance Account contained in the General Capital Fund thereby increasing Ordinance 24-2008 to \$156,750.00 and to amend the purpose of Ordinance 24-2008 to purchase a multi-use municipal loader mounted on a heavy duty truck chassis; and

WHEREAS, the Director of Finance has attested to the availability of the funds in the Fund Balance Account contained in the General Capital Fund in an amount not to exceed \$6,750.00 for this purpose; and

WHEREAS, the Borough Council has determined that the Borough should amend Ordinance 24-2008 to appropriate an additional \$6,750.00 from the Fund Balance Account contained in the General Capital Fund thereby increasing Ordinance 24-2008 to \$156,750.00 and to amend the purpose of said Ordinance 24-2008 to purchase a multi-use municipal loader mounted on a heavy duty truck chassis.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Madison, in the County of Morris and State of New Jersey, as follows:

SECTION 1: Ordinance 24-2008 is amended to appropriate an additional \$6,750.00 from the Fund Balance Account contained in the General Capital Fund thereby increasing Ordinance 24-2008 to \$156,750.00, and is amended as to the purpose of Ordinance 24-2008 to purchase a multi-use municipal loader mounted on a heavy duty truck chassis.

SECTION 2: The budget of the Borough is hereby amended to conform with the provisions of this Ordinance.

SECTION 3: This Ordinance shall take effect as provided by law.
