

## **Electric Utility Rebate Program**

If you are a full-time resident of Madison with an annual income in the ranges specified below, you may be eligible for a one-time credit this year of \$150 on your electric utility bill. If your monthly bill is less than \$150, then whatever amount is left over will be applied to the following months' bills until it is used up. The conditions for eligibility in this program are as follows:

1. Your total annual income satisfies one of the following criteria.
  - a. You live alone and your annual income is \$40,000 or less,
  - b. Your household size is two people and your combined income is \$60,000 or less. You live with a spouse/partner, or are a single parent with a dependent child living with you,
  - c. Your household size is three or more and your income is \$70,000 or less. You live with a spouse/partner and have at least one child who lives with you or you are a single parent and have two or more children living with you
2. You must provide independent verification of your income and proof of how many people are in your household. As an example, your Federal or State tax filing may satisfy these conditions.
3. The electric utility bill for where you live is in your name.
4. You must be a full time resident of Madison.

Applications must be filed no later than December 1st of each year.
